### Membership Obligations

TMCC is a self-help club. All members shall equally share the responsibility for the operation, maintenance and the carrying out of special projects and improvements.

Senior Members must contribute at least 20 hours per season, excluding launch and haul out, to help maintain the Club. As part of that commitment, all Senior Members are expected to perform the role of Duty Officer for one day per season. Associate Members are expected to contribute a minimum of 10 hours.

### Liability Insurance

All members are required to have valid liability insurance in the amount of \$1,000,000.00 more and that proof of that coverage may be demanded at anytime.

### Statement of Membership Liability Waiver and Acceptance of Fee Structure

Toronto Multihull Cruising Club ("Club") shall not be liable for any damages arising from personal injury, property loss or damage, sustained by the Member in attending in the Club and using Club facilities. The Member assumes full responsibility for any personal injury, property loss or damage which may be sustained by the Member in, on or about the Club facilities and hereby fully and forever releases and discharges the Club, its directors (solely in their capacity as directors), agents and employees from any and all claims present and future, whether the same be known or unknown, anticipated or unanticipated resulting from or arising out of the Member's use of the Club facilities, including but without limitation, any claims for personal injury, property loss or damage arising out of the negligence of the Club or any of its Members, agents and employees or any other persons using the Club facilities as Guests or invitees to the extent that such assumption of risk and waiver of claims does not discharge, release or relieve the Member's insurance carriers under policies covering the Member or his/her property.
